The U.S. Department of Agriculture (USDA) invites offers to sell frozen beef products pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal food and nutrition assistance programs. Acceptances will be announced no later than midnight, October 31, 2016. Deliveries are to be from December 1 to December 31, 2016.

This Solicitation identifies line items that are Coarse Ground Beef for Further Processing into Fully Cooked Items - Type 1 and Coarse Ground Beef - Type 2, which will determine the level of microbial testing required. Please review Sections 320.8.1 and 321.6 for Type 1, and 320.9 and 321.7 for Type 2, of Supplement 211, dated April 2016 for more information.

This Solicitation is subject to 8(a) offerings.

This Solicitation is a fifty (50%) Small Business Set-Aside - See FAR 52.219-6 Notice of Small Business Set-Aside. NAICS Code 311611- Business size 1,000 employees or less apply to this requirement.

This Solicitation is a ten percent (10%) Service Disabled Veteran-Owned Small Business (SDVOSB) Set-Aside.

The Solicitation may show multiple stops on some line items, however, the number of stops will be limited to a maximum of three. However, a price is required on all line items within the lot.
