The U.S. Department of Agriculture (USDA) invites offers to sell chicken strips pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, Friday, November 18, 2016. Deliveries are to be made between January 1, 2017 and March 30, 2017.
