Vegetables shall make up at least 25 percent of the net weight of the finished product as verified through drained weight of pieces of the specified size using a ½ inch sieve. The potato component shall be at least 15 percent of the net weight of the finished product, and the carrot component shall be at least 10 percent by weight of the finished product as determined by the drained weight of pieces of the specified size using a ½ inch sieve.
