- A. Raw Shelled Peanuts purchased for this Domestic Commodity Invitation shall be:
  - 1. Graded by United States Department of Agriculture (USDA), Agriculture Marketing Service (AMS), or their official agents. An AMS Milled Peanut Inspection Certificate is required.
  - 2. USDA, AMS Transfer Clearance Certificate (Peanuts) for all hopper rail shipments.
