The U.S. Department of Agriculture (USDA) invites offers to sell Pork Products pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due by 1pm CT on February 8, 2023. Acceptances will be announced by 5pm CT on February 15, 2023. Deliveries are to be made between April 1, 2023, and June 30, 2023.
