The U.S. Department of Agriculture (USDA) invites offers to sell Catfish Products pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due by 1pm CT on March 3, 2023. Acceptances will be announced by 5pm CT on March 10, 2023. Deliveries are to be made between May 1, 2023, and September 30, 2023.

This solicitation is a one hundred percent (100%) Small Business Set Aside for Material 110390 Catfish Flts - See FAR 52.219-6 Notice of Small Business Set-Aside. NAICS Code 311611 Business size 1000 employees or less apply to this requirement.

This solicitation may show multiple stops on some line items; however, the number of stops will be limited to a maximum of three.
