The U.S. Department of Agriculture (USDA) invites offers to sell Beef Products pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due by 1pm CT on May 8, 2023. Acceptances will be announced by 5pm CT on May 15, 2023. Deliveries are to be made between July 1, 2023, and September 30, 2023.
