The CID references two different manufacturing processes for a similar type of cracker (soda vs saltine), USDA Commodity Procurement has the option to allow both with purchasing this product.

Contractor must demonstrate successful delivery of a specific amount of truckloads of the product in order to be removed from probationary status on future solicitations. Any delivery problems directly attributable to the Government will not be held against the contractor.
