The U.S. Department of Agriculture (USDA) invites offers to sell Beef Products pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due by 1pm CT on August 3, 2023. Acceptances will be announced by 5pm CT on August 10, 2023. Deliveries are to be made between October 1, 2023, and December 31, 2023.

Destination quantities listed are estimates and subject to adjustment based on offerings, changes in recipient needs, market conditions, and program operations.
