The U.S. Department of Agriculture (USDA) invites offers to sell frozen beef products pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal food and nutrition assistance programs. Acceptances will be announced no later than midnight, August 18, 2023.

Deliveries are to be from October 01, 2023 to October 31, 2023.

This Solicitation identifies line items that are Coarse Ground Beef for Further Processing into Fully Cooked Items - Type 1, which will determine the level of microbial testing required. Please review Sections 320.8.1 and 321.6 for Type 1 of Supplement 211, dated April 2023 for more information.

All line items for this solicitation identified as Coarse Ground Beef - Type 2, which determines the level of microbial testing required. Please review Sections 320.9 and 321.7 for Type 2, of Supplement 211, dated April 2023 for more information.

This Solicitation is a thirty (30%) Small Business Set-Aside - See FAR 52.219-6 Notice of Small Business Set-Aside. NAICS Code 311611- Business size 1,000 employees or less apply to this requirement.

This Solicitation is a ten percent (10%) Service Disabled Veteran-Owned Small Business (SDVOSB) Set-Aside.

The Solicitation may show multiple stops on some line items, however, the number of stops will be limited to a maximum of three. To determine the number of destinations review the "Tendering Text" for the lot, which will indicate the City and State for each stop. Bidders may submit different prices for each stop. However, a price is required on all line items within the lot.

Offerors who intend to use more than one processing plant and shipping point for contracts awarded under this solicitation, other than the processing plant and shipping point entered in their bids, may submit a list of their approved processing plants and shipping points on a separate sheet of paper to be uploaded in WBSCM, and to be submitted with their bids.
