The U.S Department of Agriculture (USDA) requests offers to sell Canned Vegetables Products pursuant to the attached Invitation for Bids (IFB) solicitation document for use in the National School Lunch Program (NSLP) and other Federal Food and Nutrition Assistance Programs. Awards will be announced by Midnight, October 31, 2023. Deliveries are to be made between January 1, 2024 through June 30, 2024.

There is a probationary period for new-to-AMS contractors and existing contractors bidding on new products in which awards are limited to 10 truckloads per product. Contractor must demonstrate successful delivery of at least five (5) truckloads of [new] product in order to be removed from probationary status on future solicitations. For the purposes of this rule, successful delivery is defined as product delivered on-time and in acceptable condition according to the terms and conditions of the contract.

Suppliers of food purchase programs administered by the USDA Agricultural Marketing Service (AMS) for awards made beginning July 1, 2023 will no longer be required to use high security seals on trucks, railcars, vessels and other transports when transporting food products purchased to support those programs; traceable tamper evident flat metal, wire or plastic commercial security seals will be permissible.
