The U.S. Department of Agriculture (USDA) invites offers to sell Dried Fruit pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, February 4, 2025. Deliveries are to be made between April 1, 2025 and June 30, 2025.

Type V - Zante Currant Raisins, Unseeded, will not be permitted to be used in any of the raisin purchases.

The raisins may be lightly coated with vegetable oil (not to exceed 0.1%, by weight) for all size packages, or for use in Dried Fruit and Nut Mix.

FRUIT AND NUT MIX - Mixture Tolerance: Plus, or minus (+/-) 5 percent of each ingredient.

CRANBERRIES DRIED PKG-300/1.16 OZ - Optional added oil: Must be less than 1.0 percent by weight.

** For a new-to-USDA contractor and existing contractors who are bidding on new products, a probationary period may be implemented in which awards are limited to 10 truckloads per product. Contractor must demonstrate successful delivery of at least ten (10) truckloads of product in order to be removed from probationary status on future solicitations. These requirements are codified in 21 CFR 101.2, 101.3, 101.4 and 101.5. Purchases will be made on an f.o.b. destination basis to cities on this Solicitation. Destination quantities listed are estimates and subject to adjustment based on offerings, changes in recipient needs, market conditions, and program operations.

All prime vendors are reminded that they are prohibited from subcontracting with companies or individuals that have been suspended or debarred.

Offers must be submitted electronically via the Web-Based Supply Chain Management System (WBSCM). Offers submitted by any means other than WBSCM will be deemed nonresponsive.
