The U.S. Department of Agriculture (USDA) invites offers to sell WHOLE EGGS AND EGG PATTIES pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due on February 14, 2025. Acceptances will be announced by 5:00 pm CT on February 28, 2025. Deliveries are to be made between April 1, 2025 through June 30, 2025.

* * For a new -to-USDA contractor and existing contractors who are bidding on new products, a probationary period will be implemented in which awards are limited to 10 truckloads per product. Contractor must demonstrate successful delivery of at least five (5) truckloads of product in order to be removed from probationary status on future solicitations. For the purposes of this rule, successful delivery is defined as product delivered on-time and in acceptable condition according to the terms and conditions of the contract. 471.1 For Contractors with a freezing process that may require additional time, such as shipping to cold storage for freezing, an extension may be requested up to 96 hours. Requests shall be submitted and approved by SSD prior to date processed. Contractors shall submit one of the following:

471.1.1 Data demonstrating that the microbiological limits set forth in the FPPS during the longer freezing period are maintained after the product is thawed, opened, and stored in refrigeration up to the use by time stated on the label or,

471.1.2 An approved FSIS waiver for SSD review and approval.

This Solicitation may show multiple stops on some line items; however, the number of stops will be limited to a maximum of three. To determine the number of destinations, review the "Tendering Text" for the lot, which will indicate the City and State for each stop. Bidders may submit different prices for each stop. However, a price is required on all line items within the lot.

For offshore destinations (Puerto Rico, Hawaii, etc.), offerors have the option to choose to enter their bids direct to the offshore destination or to the port. Purchases will be made on an f.o.b. destination basis to cities on this Solicitation. Destination quantities listed are estimates and subject to adjustment based on offerings, changes in recipient needs, market conditions, and program operations.

The Government reserves the right to reject, in total or in part, manufacturers lots, sub-lots, production dates or the like when non-conforming product is identified.
