Questions and Answers for SEC 32 Canned Fruit

Questions are in **Blue**, Answers are in **Red**

1. The solicitation specifies that “All fresh fruits used for this solicitation must be sourced from the 2024 crop year harvest.” Is the use of 2025 crop year allowable?
  - Yes, moving forward, all fresh fruits used for this solicitation must be from the 2024 crop year OR NEWER.
2. The Pre-Solicitation Notice mentioned Materials (100258) - APPLE SLICES FRZ CTN-30 LB, (110541) - APPLESAUCE UNSWEETENED CAN 6/10, (110361) - APPLESAUCE CUP-96/4.5, and (100207) - APPLESAUCE CAN-24/300, however the solicitation only references Materials (110361) and (100207). Is there going to be another solicitation for Materials (100258) and (110541)?
  - The orders that have been received, were published on this solicitation.
3. Will the delivery dates of Material (110361) - APPLESAUCE CUP-96/4.5 be extended through December 31, 2025?
  - At this time, the solicited delivery periods will remain unchanged. Should we experience significant shortfalls or unfilled volume there may be an opportunity to adjust the requested delivery periods and re-solicit
