1. Is this purchase for ANY Frozen Fruit or ONLY the 3 materials specifically outlined on the solicitation (APPLE SLICES FRZ CTN-12/2.5 LB, BLACKBERRY IQF CTN-12/2.5 LB, APRICOT FRZ CUP-96/4.5 OZ)?
