COLONY, HONEY PLANT AND MARKET CONDITIONS DURING FEBRUARY 2024

APPALACHIAN DISTRICT (MD, PA, VA, WV) : The month of February was pretty much about normal for temperatures, but below average for precipitation including snowfall events. Beekeepers were checking on food supplies to maintain colonies. There were a few small patches of early blooming plants (skunk cabbage, crocus) bloom at the end of the month and beekeepers reported some pollen foraging by their bees especially in the southern part of the District.

ALABAMA: In Alabama, the month of February started with normal temperatures throughout the state, and drought or abnormally dry conditions in northern areas. As February progressed, temperatures were slightly above average, and precipitation in mid and northern regions resulted in easing of previous drought conditions that had persisted for several months. Despite recent precipitation, beekeepers still reported low honey reserves, likely because spring nectar flows had not come online in full force. Therefore, some beekeepers fed their colonies. Few swarms were reported, and drone brood was reported, starting early in the month. Red maple bloomed throughout the state during the month; by mid-February it's bloom had completed in the south. Henbit, Japanese camellia,

callery pear, and dandelions bloomed too, so too did Chickasaw plum and fetterbush in the south. Mustard cover crops also were in bloom throughout the state.

ARIZONA: The month of February was encouraging for rainfall in many parts of the state. According to the Arizona State Climate Office, the rainfall was about 1.39 inches for the month. This is higher than average of .84 inches for the month-to-date. Though this does not entirely solve the problem of drought, it does help to improve growing conditions of flowering plants.

We have still seen a reduction in bee hives present in the state. As with January, many bee hives are still present in bordering states (e.g. California) for nut tree and other yearly pollination projects. The increased rainfall has given many beekeepers optimism as citrus trees are in full bloom.

The demand for honey once again remains good throughout most of the state. Many bees are currently out of state, but preparations are being made to return the hives back to Arizona in upcoming months.

ARKANSAS: During the month of February temperatures were well above normal across most of the state. Precipitation was about normal across most of the same area. According to the U.S. Drought Monitor website, most of the state had normal soil moisture. Too few prices exist to establish a current market price for wholesale white honey.

CALIFORNIA: No report issued.

FLORIDA: Temperatures were about normal for the month while precipitation was slightly above average in South Florida and slightly below average in North Florida. Bee health was considered to be a little better than average partly due to a relatively mild winter and early spring. Many beekeepers were splitting hives and treating for mites with generally good results in the northern areas. After the middle of the month many were also requeening hives. There were few natural sources of food with supplemental feeding required in northern Florida. There were instances of bees being lost to Yellow Jasmine due to the lack of other natural sources of food for the bees in northern areas. Orange bloom began in Central and South Florida around the 20th and is expected to continue for about a month. Willow and saw palmetto were also blooming providing some food for the hives. Supplemental feeding was much less necessary in the south. Treatments for mites and hive beetles were not as effective as many beekeepers expected in Central and South Florida. Most of the orange blossom honey will be pulled in March. Bees were being transported to California for the almond pollination season with high freight rates being experienced. Other bees were pollinating blueberries in Florida and Georgia. There was little honey available for sale during the month with also almost no honey stored at the end of the month.

GEORGIA: No report issued.

IDAHO, COLORADO, UTAH: During the month of February temperatures were average in Idaho. Precipitation in Idaho was normal. Utah had temperatures that were average and precipitation that was above average. Colorado had normal temperatures across the whole state, Precipitation for Colorado was above average for February.

According to the U.S. Drought Monitor website, in February Southern Idaho had no drought and Northern Idaho had moderate to severe drought. Utah is currently under no drought to abnormally dry conditions in Southeast Utah. Colorado had normal soil moisture to severe drought in Southwestern Colorado. Producers have their hives in California for almond pollination.

Prices for the month of February were between \$2.85 and \$3.20 per pound with a mostly price of \$3.00 for Idaho, Colorado prices have too few producers reporting to determine a market. Prices for locally sourced honey in Utah are \$2.50-\$3.30 per pound with mostly \$3.00 to \$3.30.

ILLINOIS: The weather for February has been mild with a few cold days of rain or snow. Most beekeepers report their bees in good condition. Beekeepers are going to meetings and checking and repairing equipment and report that lots of packages are being ordered. Demand for honey is good and demand exceeded supply at the retail level and demand was fairly good at the wholesale level. Prices are generally unchanged.

INDIANA: The weather has been good for February with warm temperatures and a few days of precipitation. Beekeepers are checking on the bees from winter. Most beekeepers report that their bees are in good condition, while others report some dead hives. Beekeepers are going to meetings, checking and repairing their equipment and preparing for the spring. Demand for honey is good at the retail level and fairly good at the wholesale level. Prices are generally unchanged.

IOWA, KANSAS, MISSOURI, NEBRASKA: No report issued.

KENTUCKY: Beekeepers enjoyed one of the warmer February months in recent memory, with willows, maples, witch hazels and early spring flowers such as snowdrops, hellebores, crocus and daffodils providing much-needed pollen. There have been winter losses, with most beekeepers attributing their losses to the severe cold temperatures in January. Early hive inspections showed good build-up of brood and, for the most part, plenty of winter honey.

LOUISIANA: During the month of February temperatures were well above normal across most of the state. Precipitation was about normal across the state. According to the U.S. Drought Monitor website, abnormally dry conditions exist across central Louisiana. Northern and Southern parts of the state show normal soil moisture. Too few prices exist to establish a current market price for wholesale white honey.

MICHIGAN: Michigan's Upper Peninsula is experiencing an unusually warm and dry winter with February being no exception. No snow on the ground and multiple days warm enough to feed is a big bonus for U.P. beekeepers! Even reports of pollen returning to the hives. The warmer than usual temperatures and resulting fog/mist have caused some problems with moisture build up and many U.P. beekeepers have lost their hives. Hopefully the warmer temperatures are here to stay and we can continue to feed into spring. Wildflower honey retails for \$9.00 pound.

MINNESOTA: During the month of February temperatures were above average across the whole state. Precipitation for February was normal for the North end of the state, the South end of the state saw normal precipitation as well.

According to the U.S. Drought Monitor website, in February the whole state had abnormally dry to moderate dry soil moisture with a small spot of severe drought up north.

Producers have their hives in California for almond pollination.

Prices per pound in Minnesota were \$2.80-\$3.00 with mostly price of \$2.80-\$3.00 for locally sourced honey for the month of February.

MISSISSIPPI: No report issued.

MONTANA: No report issued.

NEW ENGLAND: No report issued.

NEW YORK: February in NYS brought above average temperatures interspersed with occasional snowy winter storms. Counties in west/central NY continue to be abnormally dry. Reports of strong colonies beginning to brood, requiring more care and feeding, with some colonies succumbing to starvation due to increased activity during the warmer temperatures. Beekeepers anticipate splitting their hives a bit earlier than usual in the Spring. Some maples are beginning to bloom, providing pollen for brooding colonies. Honey sales strong with good prices.

NORTH CAROLINA: No report issued.

NORTH & SOUTH DAKOTA: In the Dakotas water supplies have been adequate and the winter generally not hard. For many of the bees on the West Coast the almond crop is at the forefront. By mid-February hives were in the orchards. Reports of rain in many areas and some wind, but the bloom was considered to generally be good overall, with enough days of good flight weather.

OHIO: Northwest Ohio: Second warmest February on record and least amount of snow for Northwest Ohio. Bees have been flying since the second weekend. Natural pollen has been coming in for the last week to ten days. Possible early spring build up and swarm season. Honey prices have remained stable at \$5.50-\$6.00 per pound wholesale and \$9.00-\$16.00 retail.

West Central Ohio: February has been warmer than usual, about 8 inches of snow total for the month, above normal for rain fall, 5 inches, ground is saturated. The Sugar maple sap crop was better than usual this year. The maple trees are in full bloom, producing both pollen and nectar, many early wild flowers are in full bloom, honey bees have had several days of harvesting from the flowers. The trees and flowers at Wright-Patterson started to bloom on Feb 18. The temperature swings in the last 2 weeks have been from 8 degrees to 70 degrees. On February 28th surrounding 6/7 counties near Wright-Patterson Air Force base, the US Weather Service confirmed 5 tornados touched down. One touched down in area B near the Air Force Museum, damaging one of the storage hangers. Area A escaped damage where the honey bee colonies are in hives plus in the large Bee Trees. Beekeepers with Feral Ohio Local Adapted Honey Bees have very low winter loss, the colonies are very strong. Those beekeepers that bought commercial bees last year have losses now at 70%.

Ohio: February was warmer than usual then ended very cold. Many beekeepers were able to open hives and check the health of their colonies in the third week of the month. Reports are opposite extremes, some with a 50-70% loss, while other have a 90% survival. In Cleveland, the average temperature for February was 47.5 F with a low of 16 in mid-February, reaching 71 at the end of the month. Only 3 inches of snow fell the entire month. Toledo had a similar pattern with a high of 73 degrees on the 27th, then 16 degrees February 16-17. In the Cincinnati area, it also had the warmest temperatures (71) at the end of the month with a monthly average of 53.8 degrees. Central Ohio experienced four tornados on February 28, one each in four counties. Several buildings and home were destroyed with the early morning storm.

The red maple is in full bloom in the Cincinnati area with the silver maple fading. Both are excellent pollen sources for honey bees and other pollinators. Silver maple is in full bloom in Central Ohio with red maple in first bloom. The Cornelian cherry and silver maple are in first bloom in the Cleveland area, hopefully the bees were able to access it before the temperatures dropped again.

OKLAHOMA: During the month of February temperatures were well above normal across most of the state. Precipitation was slightly below normal across the state. According to the U.S. Drought Monitor website, Oklahoma had mostly normal soil moisture across most of the state with an abnormally dry area across the Southeast part of the state. Too few prices exist to establish a current market price for wholesale white honey.

OREGON: No report issued.

SOUTH CAROLINA: No report issued.

TENNESSEE: February major nectar and pollen sources for Tennessee, included Red Maple and Henbit. Beekeepers are reporting early build-up of colonies on these sources of nectar and pollen. Local honey is currently selling for an average of \$16 a pound across the state at the retail level. February weather was up and down with alternating periods of warm weather and cold periods. For the most part bees are doing well, but there have been reports from across the state of a few beekeepers having heavy losses.

TEXAS: During the month of February temperatures were well above normal across most of the state. Precipitation during February was about normal across most of the state. According to the U.S. Drought Monitor website, North, South and East Texas had normal soil moisture. West Texas was abnormally dry to severe with an area of moderate to extreme drought in an area West of San Antonio. Too few prices exist to establish a current market price for wholesale white honey.

WASHINGTON: The talk in Washington is around snowpack moisture content. With dry weather, and warmer temperatures the snowpack moisture content is well below normal. Some limited precipitation added to soil moisture at lower elevations, but the snowpack still remains low causing concerns for later season irrigation.

WISCONSIN: The weather for February has been mild overall with warm temperatures and very little precipitation. Beekeepers have been checking on the bees to see how they are doing. Some beekeepers are deciding whether or not to feed their bees. Beekeepers are also going to meetings, checking and repairing equipment, ordering packages, preparing for the spring and participating in beekeeping classes. Demand for honey is good at the retail level and fairly good at wholesale level. Prices are generally unchanged.
