- All cattle at monthly stocker sales. 6 % of gross proceeds of sale.
- All re-sales 3 % of gross proceeds of sale.
- All no sales 6 % of last bill.

- All livestock \$ 1.50 per head.

SECTION 3 – RESALES AND NO SALES

SECTION 4 – VETERINARY SERVICES

The schedule of charges on all necessary veterinary services performed by an Accredited veterinarian will be at posted uniform per head rates, pursuant to company Agreement, with the veterinarian performing such services and does not contain any Charges retained by the market.

SECTION 7 - SPECIAL SALES OR SERVICES

SECTION 8- INSURANCE LIVESTOCK

All livestock while on the stockyard premises are insured against fire and/or lightning, windstorm, cyclone, tornado, hail, smothering and other accidental means, including destruction of animals to immediately relieve suffering resulting from accidental means in keeping with the conditions and limits of the insurance policy in force and effect.

The charges will be posted rates pursuant to an insurance policy on file with the USDA, GIPSA and does not contain any charges retained by the insured market.
