Charge Classification

Section A: Selling Commission

- 1) **Bovine**
 - A. Cattle and calves 3% of gross proceeds or \$18.00 per head minimum
 - B. Slaughter bulls (over 1000 pounds) \$38.00 per head
 - C. Dairy Cows \$19.00 per head
- 2) **Goats and Sheep**
 - A. ALL 6% of gross proceeds or \$6.00 per head minimum
- 3) **Swine**
 - A. Weiner pigs (80 pounds & under) 6% of gross proceeds or \$6.00 per head minimum
 - B. Feeder pigs (81-169 pounds) 6% of gross proceeds or \$7.00 per head minimum
 - C. Butcher hogs (170-250 pounds) 6% of gross proceeds or \$8.00 per head minimum
 - D. Hogs (over 250 pounds) 6% of gross proceeds or \$10.00 per head minimum
 - E. Family of hogs 6% of gross proceeds or \$15.00 per family minimum
- 4) **Horses and Burros**
 - A. Burros \$8.00 per head
 - B. Ponies, colts & fillies (under 800 pounds) \$15.00 per head
 - C. Horses & Mules (800-1000 pounds) \$25.00 per head
 - D. Horses and Mules (over 1000 pounds) \$35.00 per head
 - E. Mare and foal \$35.00 per pair

Section B: No Sales & Pass outs

- A. Baby Calves, goats, sheep & pigs \$5.00 per head
- B. Cattle over 150 pounds \$10.00 per head
- C. Burros \$5.00 per head
- D. Horses & Mules \$15.00 per head

Section C: Tack Commissions and Pass Outs

- A. Tack Commission 20%
- B. Saddle Commission 10%
- C. Trailer Commission 7%
- D. Tack Pass Out \$2.00 per Item
- E. Saddle Pass Out \$5.00 per Saddle
- F. Trailer Pass Out \$25.00 per Trailer

Section D: Yardage

- A. All Livestock \$2.00 per head

Section E: Insurance

- A. All Livestock 0.15 per \$100.00 of gross proceeds

Section F: Feed

The charge for feed will be average cost delivered at the Stockyard, Plus \$0.50 cwt.

Section G: Special Sales

Special sales or unusual stockyards services such as and including featured registered Cattle and calf sales, annual 4H sales, and sales for one consigner held on other than regular sale days, which require special service and handling will be charged under special arrangements agreed to between the parties prior to the sale.

The charges on all veterinary services by an accredited veterinary will be on a per visit basis.
