Section 1. Selling Commission

1. Cattle
 - a. All Classes & Calves minimum 3.75% of gross sales with \$17.50/hd
 - b. No Sale Charge 1.88% of gross sales
 - c. Resale Charge minimum 3.75% of gross sales with \$17.50/hd
2. Horses and Mules
 - a. All Horses & Mules 10% of gross sales with \$15.00/hd minimum
 - b. No Sale Charge 5% of gross selling price
 - c. Resale Charge 10% of gross sales with \$15.00/hd minimum
3. Sheep and Goats
 - a. All Sheep and Goats 10% of gross sales \$10.00/hd minimum
 - b. No Sale Charge – No sale charges shall apply when the consignor declares his consignment no sale on price bid, bids in his consignment, or withdraws the same prior to actual sale..... 5% of gross selling price
 - c. Resale Charge – Resale charges shall apply on all livestock resold without leaving the company livestock market premises... \$5.00 per head

Section 2. Veterinary Inspection & Services

1. The schedule of charges on all necessary veterinary services performed by an accredited veterinarian will be posted uniform per-head rates, pursuant to company agreement with the veterinarian performing such services.
2. All facilities and services necessary in handling of consigned or purchased livestock in carrying out testing, vaccination, spraying, dipping and the like, will be supplied by the company at uniform per-head rates pursuant to company agreement with the accredited veterinarian performing such services.

Section 3. Feed

1. All Livestock \$0.55 per hundred weight per day
2. Horses and Mules-not weighed \$6.00 per head per day
3. Sheep and Goats-not weighed \$0.50 per head per day


Section 4. Special and Unusual Services

1. Special selling and marketing services, such as involved in featured registered cattle and calf sales not usually required in handling livestock for sale and other than specified, will be charged for under special arrangement between all parties involved prior to said sale.

Section 5. Insurance

1. The schedule of charges will be posted rates pursuant to an insurance policy on file at the livestock market and does not contain any charges retained by the insured market.
