**SECTION 1. Selling Commission**

- a. Cattle and Calves
  - 1. Selling up to \$428.50 \$15.00 per head
  - 2. Selling over \$428.50 3 ¼ percent of gross proceeds
  - 3. Re-Sales ¼ percent of gross proceeds
  
- b. Horses, Ponies, Mules, and Donkeys
  - 1. Selling up to \$250.00 by weight \$15.00 per head
  - 2. Selling up to \$250.00 by head \$20.00 per head
  - 3. Weigh horses selling by the pound 6 percent of gross proceeds
  - 4. Registered and riding horses 8 percent of gross proceeds
  - 5. Re-Sales Full Commission
  - 6. No-Sales
    - 1. Weight Horses \$10.00 per head
    - 2. Registered & Riding Horses \$20.00 per head

**Section 2. Yardage**

- a. Horses, Ponies, Mules, and Donkeys \$5.00 per head

**Section 3. Feed**

- a. All feed, as fed, shall be charged for at cost l.o.b. the market

**Section 4. Vet Inspection and Services**

- a. The schedule of charges on all necessary veterinary services performed by an accredited veterinarian will be at uniform per head rate.

**Section 5. Insurance**

- a. All livestock while on the stockyard premises are insured against fire and/or lightning, windstorm, cyclone, tornado, hail, smothering and other accidental means, including destruction of animals to immediately relieve suffering resulting from accidental means in keeping with the conditions and limits of the insurance policy in force and effect.
- b. The schedule of charges will be posted rates pursuant to an insurance policy on file with the Livestock Market and does not contain any charges retained by the insured market.

**Section 6. Special or Unusual Services**

- a. Special sales and marketing service, such as involved in featured registered cattle and calf sales, not usually required in handling livestock for sale and other than specified, will be charged for under special arrangement.
