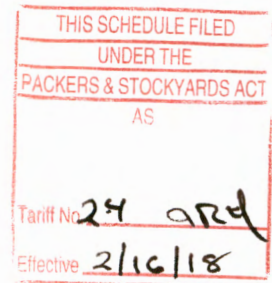

**Section C**

**Definitions**

ACCEPTANCE FOR FILING OF RATES AND CHARGES HEREIN DOES NOT CONSTITUTE A DETERMINATION OF THE REASONABLENESS THEREOF PURSUANT TO THE PACKERS AND STOCKYARDS ACT, 1921

C-1 CONSIGNMENT- For the purpose of assessing selling charges, is all the livestock delivered to the commission firm for sale.

C-2 PURCHASE ORDER- For the purpose of assessing buying charges is all the livestock purchased by a person to fill a valid order for such livestock.

C-2 A PERSON- An individual, a partnership, a corporation and/or an association of any such acting as a unit.

Except when otherwise stipulated, when livestock cross scales weighed to purchaser, delivery is final and conditional.

Market agencies are on notice by statue of that part of Section 306(f) Packers & Stockyards Act, reading- "Nor charge, demand or collect a greater or less or different compensation- Nor refund or remit in any manner any portion of the rates or charges specified."

We will not solicit nor permit anyone in our employ to solicit consignments of Livestock or influence or attempt to influence shipper of livestock in consigning their livestock or permit our employees to do so, at the drive-in docks or any point adjacent thereto outside the Oklahoma City Stockyards proper, or solicit a consignment of livestock within the stock yards after it has been consigned to a market agency.

We deny responsibility for the collection of any charges not mentioned in this tariff or those of the Oklahoma National Stockyard Company and such as are made for the convenience of the shipper and at his instructions.
