- Section 1. Selling Commission**
- A. Cows & Bulls per head 3% gross sales \$18.00/hd minimum
 - B. Cow/Calf Pairs 3.5% gross sales \$18.00/pr minimum
 - C. Dairy Cattle per head 3.5% gross sales \$18.00/hd minimum
 - D. All Other Cattle \$18.00/hd
 - E. Special Replacement Cow Sales 3.5% gross sales
1.75% or \$18.00/hd minimum
- Section 2. Resales & No Sales**
- A. All Cattle \$10.00/hd
- Section 3. Yardage**
- A. Cows, Bulls & Dairy Cattle \$3.00/hd
 - B. Cow/Calf Pairs \$1.50/hd
- Section 4. Feed**
- A. All feeding at the market shall be done by the company or under its directions. All fee charges are based on the quantity and type of feed plus 33 1/3%.
- Section 5. Insurance**
- A. Livestock
 - 1. Market Sales .0023 of gross sales
 - 2. Dairy Cattle .0030 of gross sales
 - B. Payment .0005 of gross sales
- Section 6. Veterinary Services**
- A. The schedule of charges on all necessary veterinary services performed by an accredited veterinarian will be at postal uniform per head rates, pursuant to company agreements with the veterinarian performing such services and does not contain any charges retained by the market.
- Section 7. Special or Unusual Services**
- A. Special sales & marketing service, such as involved in featured registered cattle and calf sales, not usually required in handling livestock for sale and other than specified, will be charged for under special arrangement.
- Section 8. Other Charges & Fees**
- A. Check Off money will be collected as stated by Federal and State law.
 - B. Credit Card Fee 3%
 - C. Rest-Over Cattle
 - 1. Yardage \$1.00/hd
 - 2. Rest-Over Insurance (if accepted) \$0.10/hd
 - 3. All feed as fed, shall be charged for at cost F.O.B. the market business, plus 33 1/3%.
