**Section 1 Selling Commission**

- A. Cattle
  - 1. Consignments of cattle up to \$1500 4% gross sales \$10.00/hd minimum
  - 2. Consignments of cattle \$1501+ 3% gross sales \$10.00/hd minimum
- B. Feeder Cattle 3% gross sales \$10.00/hd minimum
- C. Dairy Cattle, Bred Cattle and Breeding Bulls 3% gross sales \$10.00/hd minimum
- D. Fats (Finished Cattle) 2% gross sales \$10.00/hd minimum
- E. Butcher Cows & Bulls 3% gross sales \$10.00/hd minimum
- F. Hogs, Sows, Boars & Feeder Pigs 6% gross sales \$4.00/hd minimum
- G. Horses, Mules & Ponies 8% gross sale \$25.00/hd minimum
- H. Goats & Sheep 6% gross sale \$5.00/hd minimum

**Section 2 Yardage**

- A. Cattle, horses, mules, and ponies \$1.50/hd
- B. Hogs, goats, and sheep \$1.00/hd

**Section 3 Feed**

- A. All feed, as fed, shall be charged for at cost f.o.b. the market business.

**Section 4 Veterinary Services**

- A. The schedule of charges on all necessary veterinary services performed by an accredited veterinary will be posted at uniform per head rates pursuant to company agreement with the veterinary performing such services and does not contain charges retained by market.
- B. Inspection Fee \$1.00/hd

**Section 5 Insurance**

- A. Livestock .0016 per gross sales
- B. Payment .00046 per gross sales

**Section 6. Special or Unusual Services**

- A. Special selling and marketing services, such as involved in featured registered cattle and calf or cow sales, not usually required in handling livestock for sale and other than specified, will be charged for under special arrangement.

**Section 7 Other Charges & Fees**

- A. Check Off money will be collected as stated by Federal and State law.
