Section 3 – Veterinary Services

- a. The schedule of charges on all necessary veterinary services performed by an accredited veterinarian will be at posted uniform per head rates, pursuant to company agreement with the veterinarians performing such services and does not contain any charges retained by the market.

Section 4 – Feed

- a. Charges for hay and grain will be based on cost to the market and amount fed.

Section 5 – Insurance

All livestock consigned to this market agency are covered by insurance in accordance with an insurance policy on file with the USDA, Packers and Stockyards Administration and will be charged according to insurance company's rate.

Section 6 – Special or Unusual Services

- a. Chute Charge, Cattle Testing \$2.00 per head
b. Chute Charge, Cattle Vaccination \$2.00 per head
c. All other special selling and marketing services, such as involved in featured registered cattle and calf sales, not usually required in handling livestock for sale and other than specified, will be charged for under special arrangement.
