FOUR COUNTY AUCTION CENTER is a business that constitutes a public livestock market where, In proper facilities, it renders complete and productive stockyard and marketing services to livestock owners in respect to their livestock as assembled for sale, and which it sells on the basis of competitive bids by auction.

ITEM NO. 1 – DEFINITIONS, SERVICES

Section 1. Selling Commission

- a. The selling commission consists of the charges made by the company for the selling services performed in respect to consigned livestock.

Section 2. Yardage

- a. Includes suitable facilities and services for: Receiving and handling, safeguarding against loss, feeding, holding, weighing, delivery and shipment of livestock.

Section 3. Veterinary Livestock Inspection

- a. Includes veterinary services of accredited veterinarians under state and federal livestock sanitary regulations.

Section 4. Veterinary Services

- a. Includes veterinary services necessary, or required by state or federal livestock and sanitary regulations, which will be performed by accredited veterinarians.

Section 5. Feed

- a. All feeding at the market shall be done by the company or under its direction.

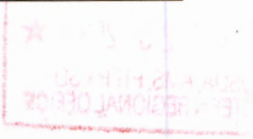
Section 6. Insurance

- a. All livestock while on the stockyard premises are insured against fire, and/ or lightning, windstorm, cyclone, tornado, hail, smothering and other accidental means, including destruction of animals to immediately relieve suffering from accidental means in keeping with the conditions and limits of the insurance policy in force and effect.

ITEM NO. II – CHARGE CLASSIFICATION

Section 1. Selling Commission

- c. **Horses** **5% of Gross Sales with a \$20.00 Head Minimum.**
- d. **Sheep & Goats** **3.75 % of Gross Sales with \$7.00 Head Minimum.**
- e. **Hog's** **3.75% of Gross Sales with \$7.00 Head Minimum**

Section 2. Yardage

- a. **All Livestock** **\$2.50 Per Head**

Section 3. Veterinary Inspection

- a. **The schedule of charges on all necessary veterinary services performed by an accredited veterinarian for inspection will be at uniform per head rates.**

Section 4. Veterinary Services

- a. **The schedule of charges on all necessary veterinary services performed by an accredited veterinarian will be at posted uniform per head rates, pursuant to company agreement with the veterinarian performing such services and does not contain any charges retained by the market.**

Section 5. Feed

- a. **All feed, as fed, shall be charged for at cost f.o.b. the market plus \$2.00 per bale.**

Section 6. Insurance

- a. **The schedule of Insurance Chargers will be at posted rates pursuant to an insurance policy On file at Four County Auction Center Inc. and does not contain any charges retained by the market.**

Section 7. Special Or Unusual Services

- a. **Special selling and marketing services, such as involved in featured registered cattle or calf sales, not usually required in handling livestock for sale and other than specified, will be charged for under special arrangement with consignors.**

Section 8. BEEF CHECK OFF

- A. **National Beef Check Off : \$1.00/head**
- B. **Texas Beef Check Off : \$1.00/head**

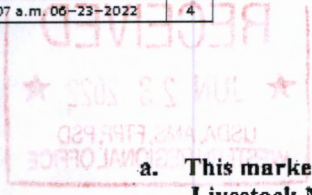
ITEM NO. III – RESALES & NO SALES

Section 1. Charge Classification

- a. **One-half the regular selling commission shall apply in respect to all resales.**
- b. **One-half the regular selling commission will be charged for No Sales.**

ITEM NO. IV – GENERAL PROVISIONS

Section 1. Code Business Standards



- a. This marketing business subscribes to the Code of Business Standards and Practices of Livestock Marketing Association as adopted by them through their business trade association.

Section 2. Allocation of Pens

- a. All pens, chutes and alleys are the property of the marketing business and may not be claimed by a selling or buying customer for his exclusive use. The management of the marketing business will assign all pens and may change such assignment without advance notice.

Section 3. Title to Livestock

- a. Title to all livestock entrusted to the marketing business for sale remains in the owners name until the time sold. Time of sale shall be at the time the highest bid is accepted unless the sale is conditional or unless proof of title in the consignor fails.
