REGULAR HOURS:

7:00 a.m. to 3:30 p.m. Monday through Friday, except holidays. Not to exceed 8 hours per day. The \$42.00 hourly rate will apply if requested services are not identified by a unit fee.

Commodity Cooperative Service Agreement Fees. In addition to all other applicable fees, commodity cooperative service agreement fees for commodity inspection services (pulses, hops, and miscellaneous processed commodities), excluding rice, will be assessed at the current percentage rate identified in FGIS Directive 9180.74 (Service Fees and Billing Codes, Attachment 4.) The assessed fees must exclude travel, mailing expenses, and state and local taxes. Invoices will identify assessed commodity cooperative service agreement fees as separate line items.

OVERTIME: \$52.50 per Individual Hour

A four-hour minimum per individual when called out on overtime.

HOLIDAY:

Holidays include New Year's Day, Veterans' Day, July 4th, Labor Day, Thanksgiving Day, Christmas Day, National Memorial Day, and Confederate Memorial Day and those granted by the Governor.

Cancellation of Shift Work - \$42.00 per each man hour if not cancelled during workday prior to schedule. Charges are assessed in half-hour increments in addition to carrier and sample fee with a minimum charge of four hours.

TRAVEL TIME CHARGE: \$42.00 per Individual Hour

MILEAGE CHARGE:

"The IRS standard mileage rate will be assessed per actual miles traveled plus travel time. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage and travel time will be prorated when it is possible."

OFFICIAL SERVICES:

Official Services not covered in this schedule will be charged at the appropriate hourly rate.
