Agricultural Marketing Act Fee Schedule

<u>Effective Date:</u> January 1st, 2024. This fee schedule supersedes all other Agricultural Marketing Act Fee schedules issued by this office. Federal Grain Inspection Service (FGIS) must approve all fees for official services and Official Agencies will assess only those fees appearing on their currently approved fee schedule. FGIS user fees included.

REGULAR HOURS

Office Hours: 6:00 AM to 2:00 PM – Monday thru Friday

<u>Inspection Hours:</u> 5:00 AM to 2:00 PM – Monday thru Friday. If you would like same day inspection, please notify us by 9:00 AM. For weekend or holiday inspection service, please notify us by 12:00 PM of the previous business day.

<u>Sampling Hours:</u> 8:00 AM to 5:00 PM – Monday thru Friday. For same day sampling, please notify us by 11:00 AM. For weekend or holiday sampling service, please notify us by 1:00 PM of the previous business day.

Overtime Hours: Hours beyond regular hours - Monday thru Friday and all day Saturday.

Double Time: Will be charged for Sundays and Holidays.

<u>Holidays Include:</u> New Years Day, Martin Luther King Day, Presidents Day, Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day, New Years Eve Day after 2:00 PM, Christmas Eve Day after 2:00 PM.

HOURLY RATES:

Regular Hourly Rate: \$42.50 per man hour, sampler/technician

<u>Overtime Hourly Rate:</u> Will be billed at one and half times the normal hourly rate and will be assessed in $\frac{1}{4}$ hour increments.

<u>Stand-by Hourly Rate:</u> Delays not caused by the agency will be billed at the applicable rate per man hour, and will be assessed in ¹/₄ hour increments.



<u>Travel Hourly Rate:</u> Billed at the applicable rate per man hour, and assessed in ¹/₄ hour increments. Prorated when possible. (Plus mileage.)

Grain Inspection Inc. reserves the right to determine the number of personnel required to properly provide the service requested.

<u>Minimum Call Out Time</u>: Two hour minimum, per person, to be billed at applicable hourly rate and prorated when possible.

<u>Mileage:</u> Mileage will be assessed at a rate of less than or equal to the IRS standard mileage rate and will be prorated when possible. Mileage rate is subject to change when the IRS rate does.

Finance Charge: 1 ½% per month after 30 days from statement date.

Per Diem - \$10 after 8 hours and \$20 after 12 hours per person.

Service requests not covered by this fee schedule will be performed at the appropriate hourly rate, plus travel time and mileage.

Special sampling handling and shipping will be charged the actual cost and sampler travel time plus mileage as applicable.

Commodity Cooperative Service Agreement Fees. In addition to all other applicable fees, commodity cooperative service agreement fees for commodity inspection services (pulses, hops, and miscellaneous processed commodities), excluding rice, will be assessed at the current percentage rate identified in FGIS Directive 9180.74 (Service Fees and Billing Codes, Attachment 4.) The assessed fees must exclude travel, mailing expenses, and state and local taxes. Invoices will identify assessed commodity cooperative service agreement fees as separate line items.
