**EFFECTIVE DATE:** January 1, 2024. This revised fee schedule supersedes all other fee schedules issued by this agency. “Federal Grain Inspection Service (FGIS) must approve all fees for official services and OAs will assess only those fees appearing on their current fee schedule.”

**OFFICE HOURS:** 8:00 a.m. to 4:00 p.m. Monday through Friday (excluding Holidays).

**BILLING METHOD:** Hourly rates are assessed in quarter-hour increments per person. Overtime and Sunday/Holiday rates are assessed in addition to unit fees. Holidays include: New Year’s Day, Memorial Day, July 4<sup>th</sup>, Labor Day, Thanksgiving, Christmas Eve Day after 12 noon, and Christmas Day. If holiday falls on a Saturday, then the holiday will be observed on Friday. If holiday falls on a Sunday, then the holiday will be observed on Monday.

<b>Overtime Hourly Rate</b>	\$24.00
<b>Sunday, Holiday Hourly Rate</b>	\$32.00

**Standby and Travel Time:** are assessed at the application rates shown above.

**On-site Inspection:** the applicable hourly rate per person, plus the unit fee.

**Mileage Rate:** The IRS standard rate for actual miles traveled, prorated where possible.

**Lodging:** Actual expenses are assessed per person when overnight stay is necessary.

Commodity Cooperative Service Agreement Fees. In addition to all other applicable fees, commodity cooperative service agreement fees for commodity inspection services (pulses, hops, and miscellaneous processed commodities), excludes rice, will be assessed at the current percentage rate identified in FGIS Directive 9180.74 (Service Fees and Billing Codes, attachment 4.) The assessed fees must exclude travel, mailing expenses, and state and local taxes. Invoices will identify assessed commodity cooperative service agreement fees as separate line items. Reference Directive FGIS 9180.74
