#### **Explanatory Notes for May 1, 2025 Official Moisture Calibration Updates**

Small changes in "loading factors" were made to optimize agreement between UGMA-Compatible units and the UGMA Master system.

Refer to UGMA-Performance\_May2025.pdf for the performance of the UGMA Master system to the Air Oven reference method for all grain groups prior to the 2025 harvest.








