Explanatory Notes for May 1, 2023 Official Moisture Calibration Updates

Small changes in “loading factors” were made to optimize agreement between UGMA-Compatible units and the UGMA Master system.

Refer to UGMA-Performance_May2023.pdf for the performance of the UGMA Master system to the Air Oven reference method for all grain groups prior to the 2023 harvest.

For grain groups with calibration updates, the following pages show the moisture changes resulting from applying the new loading factors to the 2022 crop data.

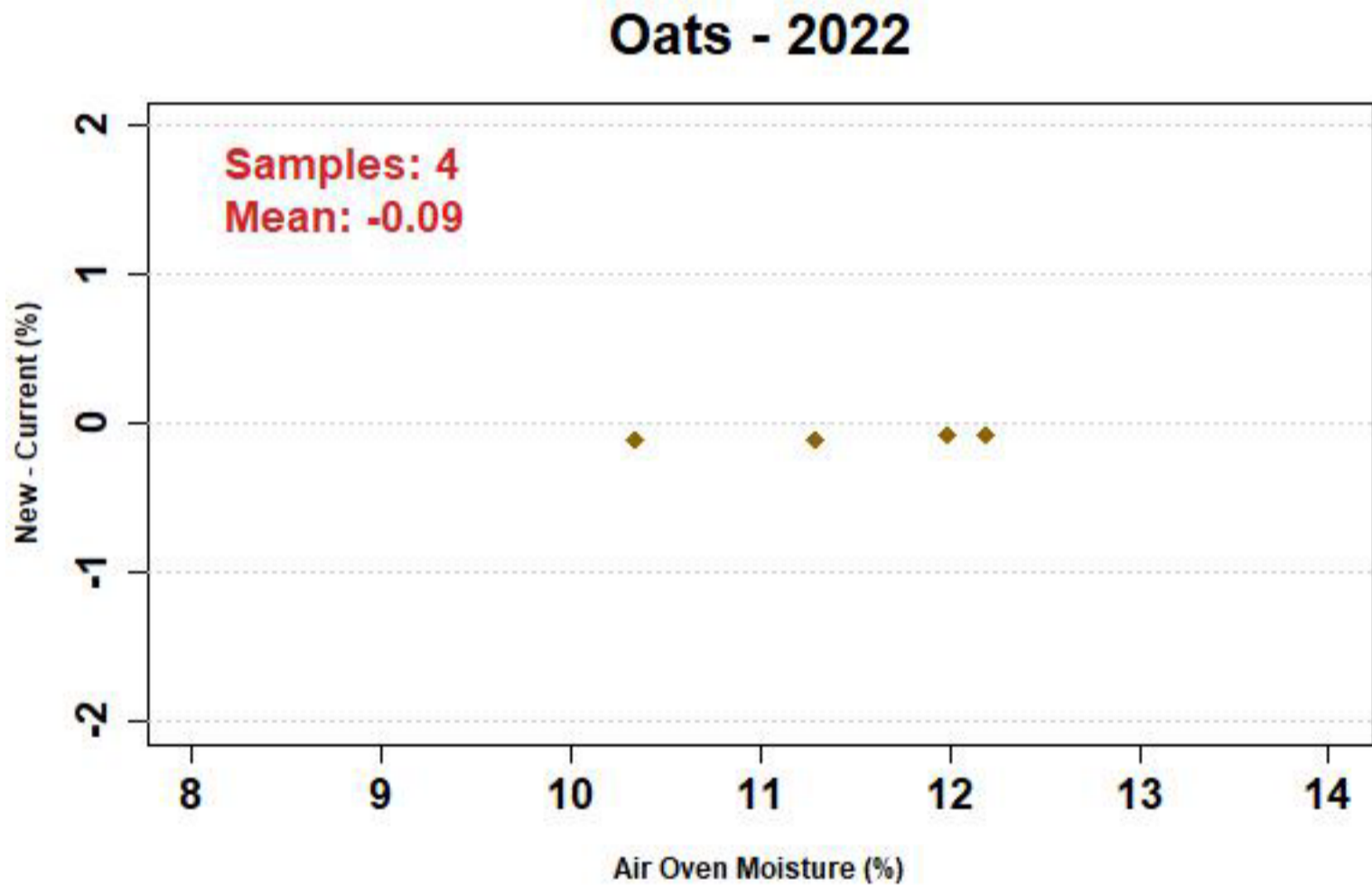

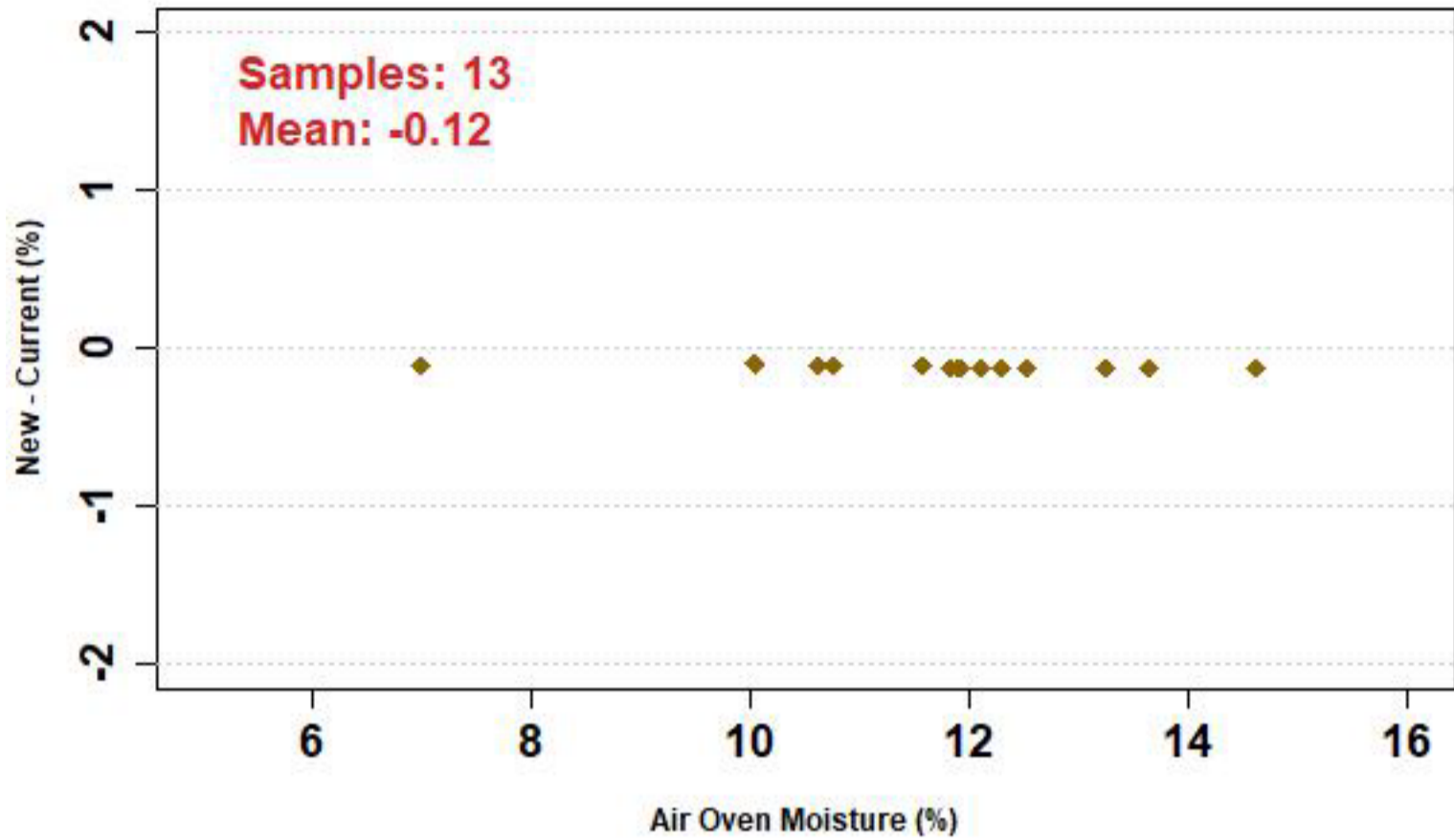
