#### 1. PURPOSE

This notice announces changes to certification procedures for Chickpeas/Garbanzo Beans and amends the data collection requirements of the United States Department of Agriculture (USDA), Agricultural Marketing Service (AMS), Federal Grain Inspection Service (FGIS), Inspection Data Warehouse (IDW).

#### 2. BACKGROUND

FGIS has updated the Agricultural Product Standards (APS) factors of seed sizing and seed count for the certification of Chickpeas/Garbanzo Beans. The new format of official inspection and weighing certificates require the reporting of all analytical results in the "Results" section of the certificate. This change will assist in generating results and reports pertaining to seed sizing and seed count.

#### 3. EFFECTIVE DATE

This program notice is effective October 31, 2024.

## 4. POLICY

Chickpeas and Garbanzo Beans have been updated to report the sizing and seed count information in the "Results" section of the certificate.

The new abbreviations and factors for Chickpeas/Garbanzo Beans are:

SPO22	Seeds Per Ounce on 22/64 Round Hole Sieve
ON20R	Beans Passing Thru 22/64 and/or remaining on 20/64 Inch Round Hole Sieve
SPO20	Seeds Per Ounce on 20/64 Round Hole Sieve
ON18R	Beans Passing Thru 20/64 and remaining on 18/64 Inch Round Hole Sieve
SPO18	Seeds Per Ounce on 18/64 Round Hole Sieve
ON16R	Beans Passing Thru 18/64 and remaining on 16/64 Inch Round Hole Sieve
SPO16	Seeds Per Ounce on 16/64 Round Hole Sieve
