	(2) When the county-level zoning is applied, there have been no outbreaks of HPAI in the County where table eggs were produced or that through which the table eggs were transported prior to packaging for at least 28 days before shipment of the table eggs; or when the County where the exported table eggs are produced has an outbreak of HPAI, there have been no outbreaks of HPAI in the County for at least 28 days before the estimated earliest date of exposure for the detection of HPAI in the County.

In the County where the table eggs were produced and where the processing plant is located, Newcastle disease (as defined in the OIE Terrestrial Animal Health Code), fowl cholera and other serious infectious fowl diseases (other than LPAI) as recognized by the government of the United States, have not occurred for at least 90 days before shipment of the table eggs.		
5.	The shell eggs covered by this certificate were processed in a plant determined by USDA personnel as meeting strict sanitary measures. A USDA grader continually monitored the operation while these eggs were processed.		
6.	. The shell eggs were washed and sanitized in accordance with USDA-approved methods.		
7.	. The eggs were packed in new and clean packing material.

Based upon documents provided by the applicant, and to the best of our knowledge, the shell eggs covered by this certificate did not originate from nor pass through any LPAI-banned area before being carried into the egg grading facility unless under official government seal noted here: Transport unit seal:
