1. PURPOSE

This Directive transmits the fee schedule and billing codes for official services performed by the Agricultural Marketing Service (AMS), Federal Grain Inspection Service (FGIS), under the United States Grain Standards Act (USGSA), and the Agricultural Marketing Act (AMA) of 1946.

2. REPLACEMENT HIGHLIGHTS

This directive revises the fee schedule for rice inspection per Federal Register (88 FR 18512), dated March 29, 2023, with changes effective April 1, 2023. Additionally, this directive provides billing codes for calculated fees, based on hourly rates, for lab testing services for rice and commodities with effective date June 1, 2023. These billing codes provide unique identifiers for billing and service tracking purposes.

This Directive supersedes FGIS Directive 9180.74, dated December 13, 2022.

3. **AUTHORITIES**

The United States Grain Standards Act, as amended

The Agricultural Marketing Act of 1946

Title 7, Code of Federal Regulations, Parts 800 and 868

4. POLICY

Fees assessed by FGIS for official services shall be reasonable, nondiscriminatory, and cover the estimated cost of the service. These costs include direct, administrative, and supervisory costs related to these services.
