Discussion

- **June 1, 2021 notes** accepted as written.
- **Ion exchange update (NOP).** The NOP met with several divisions at the Food and Drug Administration (FDA) regarding ion exchange resins to help clarify the lingering questions from the Spring 2021 NOSB recommendation. The FDA defines both food contact substances and secondary food additives, but the latter is not codified in the FDA regulations. Also, the FDA reviews ion exchange resins on a case by case basis and not as a category. The NOP will send a written summary to the NOSB, in the form of a memo to the Board, so they can determine what the next steps would be should they decide to continue to work on this.
- **Zein (JD).** The lead summarized the petitioned uses and the proposal for zein. Zein is being petitioned for addition to 205.606, as it has no known organic sources. According to the petitioner, zein has unique properties as a vegan coating for gel capsules. A member asked about GMOs and it appears that zein is not made from excluded methods. Members discussed criteria by which they review substances under OFPA. The HS presented a discussion document at the Spring 2021 meeting and intends on presenting a proposal at the Fall 2021 meeting.
- **2023 Sunset: Chlorine materials (AB).** The lead highlighted the text that was added to the draft review summarizing public comment from the April 2021 meeting. He also noted that chlorine materials are toxic, and there isn't much info about monitoring in occupational environments, while also acknowledging that there are protections and restrictions for chlorine use in place. Despite the concerns, there is support for retaining chlorine materials on the National List, and the NOSB will continue to stress the need to review the category of sanitizers. The NOSB recently discussed adding a work agenda item to explore adding a separate section on the NL for sanitizers. The HS moved to a vote.

- **January 19, 2021 notes** were accepted as written
- **2023 Sunset: Carrageenan (AB/JD).** The lead summarized his review for carrageenan, noting uses, manufacture, and International allowances. The lead described the previous review, and noted that although the NOSB voted to remove carrageenan from the National List, the NOP received public comment opposing the decision, and therefore did not remove it. The HS will seek public comment on the questions in the review at the Spring meeting.
- **Zein (JD).** The lead summarized the petitioned uses of zein, noting that it is non-synthetic. He also summarized the technical report and the HS found the TR sufficient. The lead will develop a discussion document and the HS will vote on it during the next call.
- **2023 Sunset: Animal enzymes (KH).** The lead summarized the uses and manufacturing processes of animal enzymes, and the HS will post the document for the Spring meeting.
- **2023 Sunset: Chlorine materials (AB).** The lead summarized the four substances listed under chlorine materials, noting the similarities, and associated human health and environmental concerns. Chlorine materials have a long history for use as food safety materials, and while members are concerned, they acknowledged the lack of alternatives. Discussion

- **January 5, 2021 notes** were approved as written.
- **2023 Sunset: Agar-agar (KH).** The lead summarized the draft review noting the uses and history of agar-agar. The group discussed two different extraction processes and the classification of agar-agar and potentially may work on a re-classification in the future. The lead will finalize the review and send it to NOP for the Spring meeting.
- **2023 Sunset: Calcium sulfate - mined (WT).** The lead summarized the substance and its sources, emphasizing that this version is mined. The primary concerns are mining and exposure/human health. Calcium sulfate is widely used as a coagulant in tofu, a firming agent, etc. Members discussed the need for a new TR since the previous one is from 2001. A new TR would not be completed in time for the current sunset review and would have to be for the next round. The last review was completed in 2016 and it was relisted unanimously by the full Board. The lead will submit the review to the NOP for the Spring meeting.
- **2023 Sunset: Chlorine materials (AB).** The lead introduced the substances, and noted that he reached out to stakeholders and industry members seeking additional information about the use and needs for chlorine materials, and possible alternatives. The NOSB recently hosted a panel on sanitizers, which includes chlorine materials. Members discussed human health and environmental concerns, and the view that chlorine is essential for processing and food safety. The lead will write a draft review for discussion on the next call.
- **Research Priorities.** AB reached out to several food safety experts about alternatives to chlorine materials, and it appears that research is already being conducted in this area, although it may be for conventional agriculture. The HS will keep its initial list of research priorities and not make any modifications.
- **Ion exchange filtration proposal (SE/SR).** The NOSB voted on a proposal on ion exchange filtration at the Fall 2020 NOSB meeting and it did not pass, so the HS is revisiting the proposal for the Spring 2021 meeting. Based on public comments the HS is proposing to list resins as a group, and not individually. Members also discussed the issue of food contact surfaces versus food additives. The lead will edit the document and the HS will vote on it during the next call.

- **December 15 notes** were accepted as written.
- **2023 Sunset: Silicon dioxide (SR).** The lead summarized the uses of silicon dioxide, its manufacture, environmental concerns, ancillary substances, and public comment from the last review. The lead also mentioned an NOP policy memo addressing nano-technology. The NOSB received a petition to remove silicon dioxide in 2010, but it was not recommended for removal at that time. A member asked about silica dust, which has adverse health effects, and whether or not that is pertinent to this substance. The lead will re-review the TR, add any information about manufacture that may address silica dust, add a couple of questions suggested by members, and recirculate the draft.
- **Research Priorities.** The group discussed possible Research Priorities for the Spring 2021 meeting. Members discussed sanitizers and the use of substances in rotation. A member emphasized the need for an ecosystem approach when looking at sanitizers.
- **Additional items.**
 - Ion exchange. The lead reached out to stakeholders who commented at the Fall NOSB meeting to collect more info about the use of resins and the HS will discuss it on the next call. A member had some additional questions about resins and food contact and will join the discussion with the lead and commenters.
