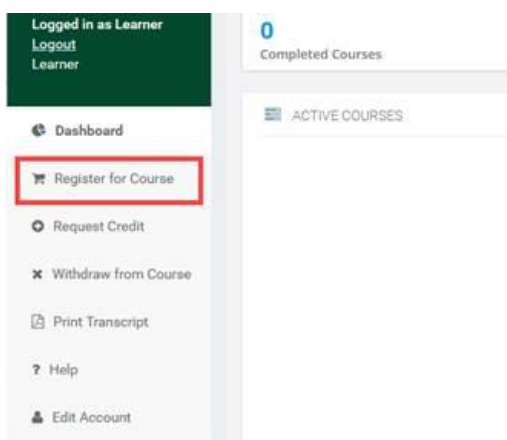

How to Register for a Course

Once you are logged into the USDA AMS National Organic Program (NOP) [Organic Integrity Learning Center \(OILC\)](#), signing up for a course is like buying a product at an online store, but all training is free.

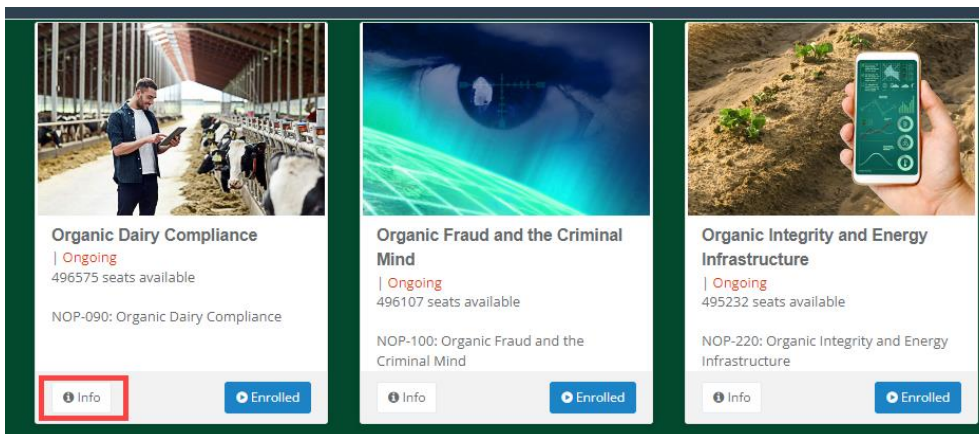
To register for an NOP course in the OILC, perform the following steps.

1. Click **Register for Course** located on the left navigation menu from the OILC dashboard.




The Registration page displays all available courses in the program.

2. For any available course, click the **Info** button to see descriptions, CEUs, keywords, and topics for that course.





Organic Dairy Compliance



This course covers a range of requirements related to livestock management, with a special focus on organic dairies. 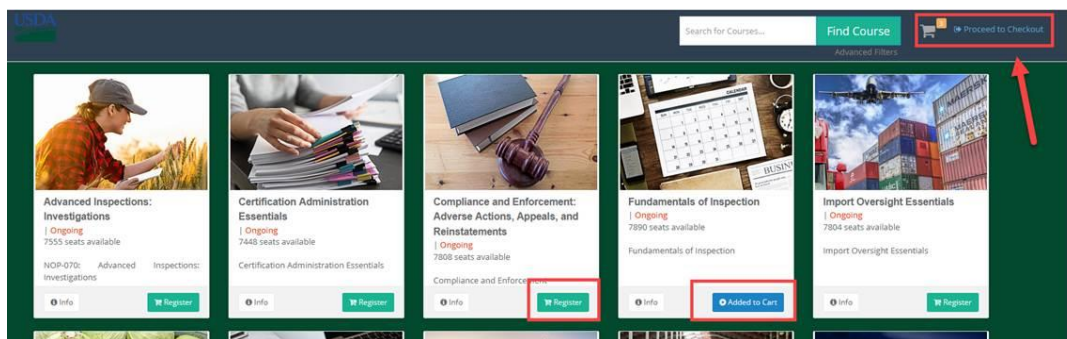
- When you finish reviewing course information, click **Close**.

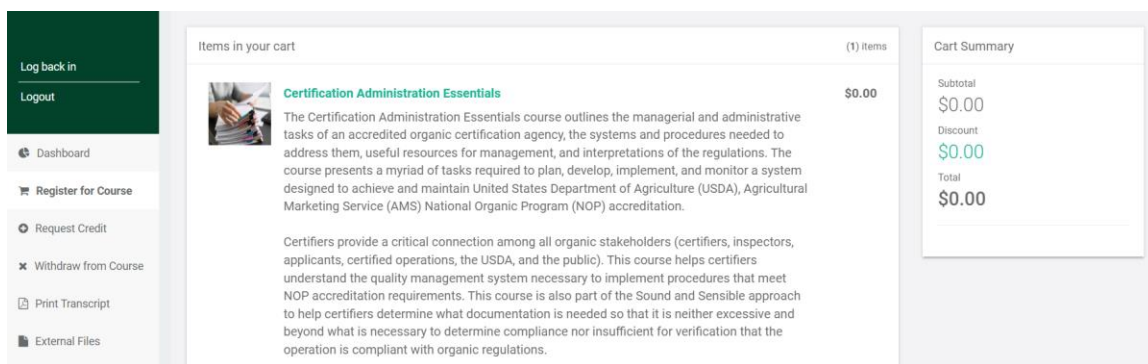

- Click the **Register** button for each course in which you would like to enroll. The Register button then changes to **Added to Cart**.

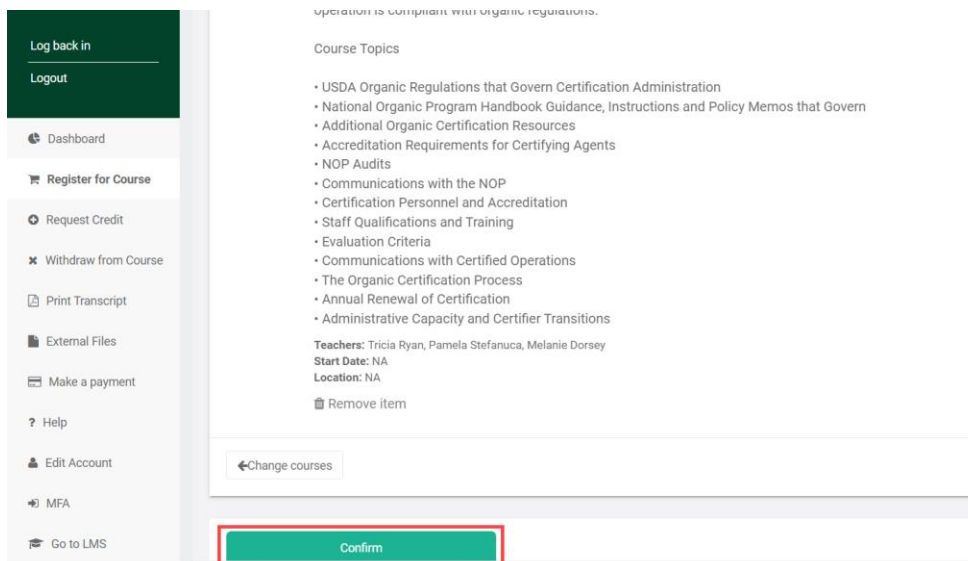


- Click the **Proceed to Checkout** link next to the shopping cart at the top of the page. The selected courses display.

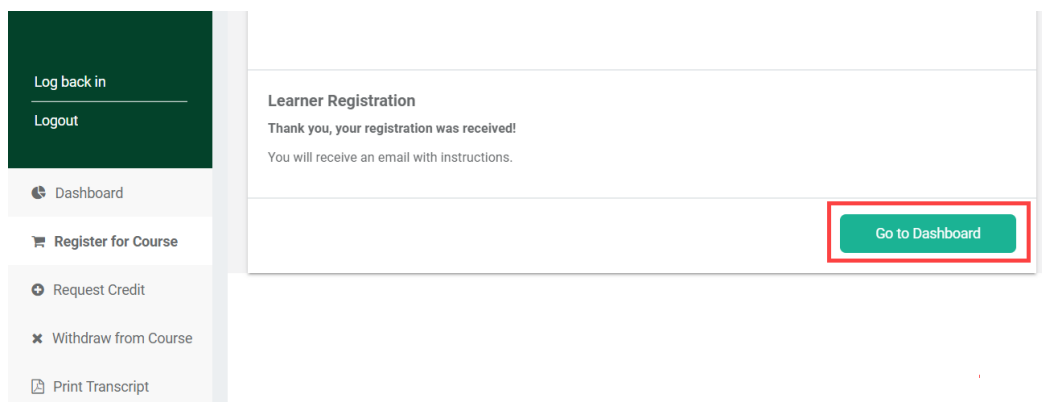

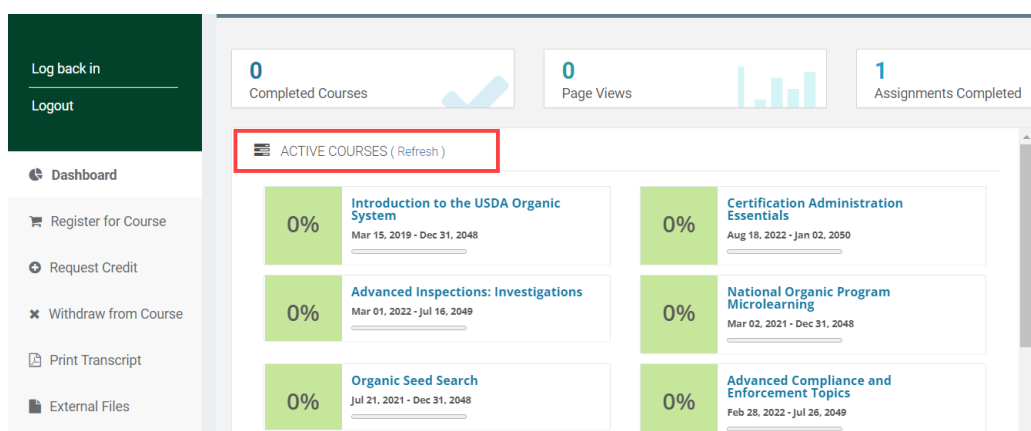
- Scroll down to the bottom of the page, then click the **Confirm** button to add the course(s) to your OILC dashboard.
