### Purchase Types- Negotiated

**Negotiated Purchase** - A cash or spot market purchase by a packer of livestock from a producer under which the base price for the livestock is determined by seller-buyer interaction and agreement on a delivery day. The livestock are scheduled for delivery to the packer not more than 14 days after the date on which the livestock are committed to the packer.



### Purchase Types- Other Market Formula

**Other Market Formula Purchase** - A purchase of swine by a packer in which the pricing mechanism is a formula price based on any market other than the market for swine, pork, or a pork product. The term "other market formula purchase" includes a formula purchase in a case which the price formula is based on 1 or more futures or options contracts.<sup>[</sup>



### Purchase Types- Swine or Pork Market Formula

Swine or Pork Market Formula: A purchase of swine by a packer in which the pricing mechanism is a formula price based on a market for swine, pork, or a pork product, other than a future or option for swine, pork, or a pork product



### Purchase Types- Other Purchase Arrangement

**Other Purchase Arrangement**: A purchase of swine by a packer that is not a negotiated purchase, swine or pork market formula purchase, or other market formula purchase; and does not involve packer-owned swine.



### Purchase Types- Negotiated Formula

**Negotiated Formula Purchase**: A swine or pork market formula purchase under which:

(1) The formula is determined by negotiation on a lot-by-lot basis; and

(2) The swine are scheduled for delivery to the packer not later than 14 days after the date on which the formula is negotiated and swine are committed to the packer.



### Purchase Types- Packer Owned and Packer Sold

**Packer Owned**: Swine that a packer (including a subsidiary or **affiliate** of the packer) owns for at least 14 days immediately before slaughter.

**Packer Sold**: The swine that are owned by a packer (including a subsidiary or affiliate of the packer) for more than 14 days immediately before sale for slaughter; and sold for slaughter to another packer



### Purchase Types- Affiliate

Affiliate: With respect to a packer, means: (1) A person that directly or indirectly owns, controls, or holds with power to vote, 5 percent or more of the outstanding voting securities of the packer; (2) A person 5 percent or more of whose outstanding voting securities are directly or indirectly owned, controlled, or held with power to vote, by the packer; and(3) A person that directly or indirectly controls, or is controlled by or under common control with, the packer.
