About Meat and Poultry Processing Technical Assistance Program (MPPTA)

The United States Department of Agriculture's (USDA) Meat and Poultry Processing Technical Assistance Program (MPPTA) program is designed to support the growth of domestic processing capacity and the ability of independent facilities to serve more customers in more markets.

The MPPTA program ensures that participants in USDA's Meat and Poultry Supply Chain initiatives have access to robust technical assistance (TA) to support their project development and success. USDA's Agricultural Marketing Service (AMS) has established a nationwide MPPTA network of technical support focusing on four key areas, or scopes:

- Federal Grant Application Management. Navigating federal grants processes and procedures, from pre-award application processes through post-award grant management compliance;
- 2. **Business Development and Financial Planning**. Business and financial planning resources, market intelligence, and project/ concept feasibility analyses;
- 3. **Meat And Poultry Processing Technical and Operational Support.** Advice and resources to support the operational needs including workforce development of processing plant development and utilization; and
- 4. **Supply Chain Development**. Support for the development and maintenance of successful supply chain and marketing relationships between suppliers, processors, distributors, and customers.



Since MPPTA's inception in 2022, we have received over 1,400 requests for technical assistance from across all 50 states, the District of Columbia, Puerto Rico, the Virgin Islands, and the Northern Mariana Islands, and 80 different Tribal Nations.



In 2024, we hosted 11 monthly education webinars reaching 1,010 people.



Our MPPTA team traveled to 143 places in 2024. These include client visits, collaborator meetings and conferences. This includes 60 site visits to assist clients in completing their grant requirements.




Sent to TA Provider- FHI has assessed the TA request and forwarded it to the appropriate TA provider. No action reported by TA provider yet.







Local Impacts from a National Commitment



The initial round of Meat and Poultry Inspection Readiness Grants (MPIRG) initiated in 2021 was offered to support smaller meat and poultry processors. Flower Hill Institute's MPPTA Regional Directors Chris Roper and Dave Carter have been visiting several processors who received those initial grants, and these visits were overwhelmingly heartening, to say the least. Double L Meat Processing

Double L Meat Processing is located in the central Appalachian region near the small town of Jonesville in southwestern Virginia. They started out processing beef and pork under USDA FSIS inspection just one day per week and have now increased inspected processing to five days per week with support from a USDA AMS Meat Poultry Inspection Readiness Grant (MPIRG) they received in 2021.

Double L Meat Processing was eager to become a USDA FSIS inspected processor. Owner Charles Layman says



that USDA inspected processing is vital to his customers who come from Virginia, Tennessee, Kentucky, and North Carolina. Charles also stated that farmers and ranchers in this region now have better access to inspected processing that was not available in this region before. With the MPIRG grant, they were able to make plant improvements and equipment upgrades to increase added value processing and increase overall capacity of processing. Click here to read more.



Makoce Agriculture Development



Nick Hernandez, founder and CEO of Makoce Agriculture Development has learned to embrace the potential of poultry production and processing to significantly contribute to building food security for the Oglala Sioux people. Now, Makoce is creating a model that incorporates choke cherry bushes, along with buffalo berry, plum, and oak trees, to create a chicken-friendly habitat. At the heart of this system is an 8' x 52' foot mobile processing unit anchored to a permanent site and being readied to serve as the first USDA-inspected poultry processing facility in all of Indian Country. Glacier Processing Cooperative

When a longtime business owner with one of the only two meat processing facilities in the Flathead Valley of Montana decided to retire, the community sprang into action. With a waitlist of 18 to 24 months for meat processing, the closure would leave local ranchers with a difficult choice: ship their livestock hundreds of miles to another USDA-approved facility or close their operations.

Concerned community members held a meeting in October 2022 to gauge interest in forming a cooperative to purchase the processing facility. Through word of mouth, the group was connected to the USDA MPPTA program. Since that first



meeting, the group has consulted with MPPTA to identify the scope of work and complete both a feasibility study & business plan.

"Had we not had MPPTA's technical support going forward, I'm pretty sure we would have all gone home in February, and that would have been the end of it," Siderius said. Click here to read more.
