NOP provided feedback about additions that would help a future board if they choose to revisit the project. Members edited the questions to stakeholders and will continue working together to finalize the discussion document. The MS will vote on its next call.

Discussion

- **June 9, 2026 notes**
- **Excluded Methods - Induced mutagenesis (CM/DN).** The lead continued talking with panelists after the spring NOSB meeting, and introduced ideas for consideration by Subcommittee members for next steps. At this time, it seems it is premature to move ahead with a proposal on IM. The biggest concern is that prohibiting it could have deleterious effects on building a robust market of organic seed. Commenters seemed to echo that they need more clarity and are concerned that it could have impacts on seed availability, specifically untreated conventional seed that organic producers rely on.
- The group talked about the market for organic seed, the fact that IM is not testable or traceable, and that excluding this method may have the opposite effect on the market. i.e., it could cause producers to use less organic seed.
- Members shared their views on various topics and how to move forward. The group discussed such things as intellectual property, whether there is a problem that needs to be solved, and how they would solve it without causing unknown deleterious effects on the industry. Initially the goal for the excluded methods project was GMO's and not to drive innovation in the seed industry.
- The hope was to move forward with a proposal for the Fall meeting however, the industry might not be in a place that would benefit organic growers. For now, the group indicated that the seed use document in CACS seems like a more viable vehicle for work on seed.
- The lead noted that research and development (R & D) in plant breeding needs to grow and strengthen before it can move ahead.
- The MS will complete a summary discussion document for the Fall meeting and place this project on hold for now. With market changes and advances in R & D there may be a path for a future board.

Discussion

- **March 10, 2026 notes** were approved.
- **Food technologist update - Mined substances (HK)**
 - HK presented findings from the research project on Mined Minerals in Organic Handling. This project was originally requested by the Board in April 2024 and includes technical information on the geographic regions, mining techniques, and environmental impacts for nonsynthetic materials at § 205.605(a) that are primarily sourced from mining. Research included TAPs and Technical Reports (TRs), reference books, and peer-reviewed research papers. Each handling material is identified as coming from one of two primary mining methods: surface mining or underground mining. The Handling Subcommittee will incorporate the information into its deliberations on sunset reviews and new petitions for materials that are sourced from mining. Board members thanked HK for the great work. If the Crops or Livestock Subcommittees want this type of information, they should submit a request for a new or amended project scope.
- **Excluded Methods - Induced mutagenesis (IM) (CM, DN).** Will revisit at the next Subcommittee meeting in June.
- **TR Template Update (AJ).** The lead presented updates to the Technical Report template to add details about various exposure pathways (farm workers, processing facility workers, other) to the question about impacts to human health. These edits would be considered clarifications for how the Board prefers information to be organized, rather than requesting new information, since technical reports already typically include this information. The Subcommittee chair will submit the updates to NOP.

Discussion

- **February 10, 2026** were accepted as written.
- **Excluded Methods - Induced mutagenesis (IM) (CM, DN).** The MS had a robust discussion about the induced mutagenesis project, which they will present as a verbal update at the Spring NOSB meeting. Since this project was newly transferred from past Subcommittee members to current ones, they are still in the information gathering stage and anticipate having a discussion document for the Fall 2026 meeting, rather than a proposal. The Subcommittee previously presented a discussion document at the Fall 2025 meeting that identified three pathways the MS could take regarding the classification of induced mutagenesis as an excluded method. One of the co-leads compiled and circulated the public comments from the last document, highlighting that commenters were divided. Subcommittee members discussed various issues and challenges in determining which pathway to choose. The group also discussed the seed panel and panelists the CACS is proposing to host at the Spring NOSB meeting, and feels that the panel could also encompass a discussion on IM. One of the co-leads asked about specific questions that they would want to pose to an expert panel. The MS may also invite speakers to future Materials calls as they work on the next iteration of the document. Members discussed the TBD list from the previous proposal, and what items are still outstanding.
- **Food technologist update - Mined substances (HK).** Deferred to future call for lack of time.
- **Additional Items.**
 - **Seed panel.** The CACS has proposed a seed panel for the Spring 2026 meeting, and the MS feels that participants would also be able to address IM questions. The group discussed potential panelists, who represent various segments of the seed community, including a USDA researcher studying breeding techniques in both the organic and conventional space. It is not clear yet whether the meeting will be virtual or in person, but the Board is supportive of hosting a panel either way. The NOSB Chair will send an email to NOP describing the goals for the panel, with the proposed panelists.
