- **March 10, 2026 notes** were approved via email.

Discussion

- **February 10, 2026 notes** were approved as written.
- **Workload reductions ideas.**

The group discussed challenges and solutions regarding workload and time constraints for Board members, especially small farmers. Members discussed how to make it easier for small farmers to participate, given unique challenges. The PDS Chair emphasized that farmers provide an important voice, and their participation is important.

A member identified a few areas that she found challenging, including finding and formatting documents, and accessing Sharepoint. Another member noted that it would be easier for small farmers if they had assistance writing documents, while they share their ideas and lend their voice to conversations.

The NOP has implemented many ideas over the years to reduce each members' workload including limiting the number of Subcommittees each members sits on, reducing the number of sunsets each member is assigned, reducing the number of "other projects" outside of sunsets and petitions, and adding full time staff to help the Board members with research.

The NOP added that having staff write proposals and reviews for Board members could be seen as having an undue influence, and is not advised. And having an outside assistant write proposals violates an NOSB rule about sharing working documents with people who are not Board members. The group will continue to talk more about this.
