



FEES FOR LABORATORY ANALYSIS

1 Purpose

This Procedure sets forth the current fees charged for laboratory analysis.

2 Scope

The provisions of this Procedure apply to all facilities utilizing Quality Assessment Division (QAD) services requiring laboratory analysis.

3 Procedures

- 3.1 Meat Graders shall ensure that laboratory analysis fees for sampling shall be emailed to [QAD-SupportService](#) and shall include the date the sample is shipped, the facility name, and the amount to be billed.
- 3.2 Designated QAD employees shall ensure that laboratory analysis fees for potential, presumptive and/or confirmed positive samples are emailed to [QAD-SupportService](#). Include a statement indicating why additional laboratory fees were incurred by the applicant. (Example: Additional laboratory fees incurred on lot xxx due to Salmonella Presumptive Positive results received on mm/dd/yy.)
- 3.3 Management Analysts shall enter all laboratory fees in the Conformance Assessment Management System (CAMS).

4 Laboratory Analysis Fees

- 4.1 Contact the QAD Office for all laboratory charges not identified in the Laboratory Analysis Fees table.
